Acuite has reviewed the long term rating of '**ACUITE BB+**' (read as **ACUITE Double B plus**) and short term rating of '**ACUITE A4+**' (read as **ACUITE A four plus**) on the Rs.10.50 crore bank facilities of synergy SKI Infradevelopment (SSI). This rating is now an indicative rating and is based on best available information.

Established in 2008 by Mr. Vishal Kadarkar and Mr. Sandeep Shitole, SSI is a partnership firm engaged in civil construction and infrastructure development. The partners possess a decade of experience in the construction industry.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
