Rating Rationale

Acuité has reaffirmed the long term rating to '**ACUITE BB-**' (read as **ACUITE double B minus**) and the short term rating of '**ACUITE A4+**' (read as **ACUITE A four plus**) on the Rs.10.50 Cr bank facilities of Synergy SKI Infradevelopment (SSI). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

Established in 2008 by Mr. Vishal Kadarkar and Mr. Sandeep Shitole, Synergy SKI Infradevelopment (SSI) is a partnership firm engaged in civil construction and infrastructure development. It is based in Pune. The partners possess a decade of experience in the construction industry

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower).
