**Rating Rationale**

Acuite has downgraded its long-term rating to ‘**ACUITE C**’ (read as **ACUITE C**) from ‘**ACUITE B**’ (read as **ACUITE B**) on the Rs.20.00 Cr. bank facilities of B U Bhandari Vaastu. The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

The rating downgrade is on account of entity being listed in the CIBIL's Suit Filed Accounts - Defaulters Rs.1 crore and above list as of 30-Nov-2024.

**About the Company**

B U Bhandari Vaastu is a Special Purpose Vehicle of the B U Bhandari group. Incorporated in 1989, the firm is currently developing a 2BHK residential project with two showrooms and eight shops under the name ‘Vaastu Viva’ in Wakad (Pune). The partners, Mr. Rajneesh M Bhandari and Mr. Anuj M Bhandari, have already infused capital of Rs.2.40 crore as on March 31, 2016. The credit facilities have already been sanctioned.

**Unsupported Rating**

**Non-cooperation by the issuer/borrower:**

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuite’s policies.
