Acuité has reviewed the long-term rating of '**ACUITE BB-**' (**read as ACUITE double B minus**) and short term rating of '**ACUITE A4+**' (**read as 'ACUITE A four plus'**) on the Rs. 10.00 crore bank facilities of Evershine Smelting Alloy Private Limited (ESAPL). This rating is now an indicative rating and is based on best available information.

ESAPL was incorporated in 1997 by Mr. S Sekar and Mrs. Maheshwari Sekar. The company manufactures lead, lead alloys and lead oxides through recycling of lead scrap. It caters to battery manufacturers in the region as well as foreign countries. The company is also a member of Metal Recycling Association of India. The company operates an ISO 9001:2008 certified facility in Bangalore (Karnataka).

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
