Rating Rationale

Acuité has reaffirmed the short term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs.10.00 crore bank facilities of Platinum Grains Private Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Delhi-based, Platinum Grains Private Limited (PGPL) was incorporated in 2009 and is engaged in trading of parboiled rice and non-basmati rice to Hong Kong and South Africa to name a few. The company exports under the brand name "Platinum". PGPL is promoted by Ms. Harnita Ahluwalia and Ms. Davinder Kaur Sehgal.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
