Acuité has reviewed the long term rating of '**ACUITE BB-**' (read as **ACUITE double B minus**) to the Rs.12.00 crore bank facilities of Bright Style Fabrics Private Limited (BSPL). This rating is now an indicative rating and is based on best available information.

BSPL was incorporated by Mr. Hari Agarwal in 2008. The company is engaged in the processing and finishing of fabrics at Bhilwara (Rajasthan). It has 60 airjet power looms with installed capacity of 5 lakh metres per month to produce grey and finished fabrics. The company caters to customers across several states including Punjab, Delhi and Uttar Pradesh through distributors. BSPL procures most of its raw materials from the local market.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
