SMERA has reviewed the long term rating of '**SMERA B (read as SMERA B) and short term rating of SMERA A4 (Read as SMERA A Four)**' on the Rs.5.85 crore bank facilities of Senthil Enterprises-JV. This rating is now an indicative rating and is based on best available information.

**Non-cooperation by the issuer/borrower:** SMERA has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.
