Acuité has reviewed the long-term rating of '**ACUITE B**' (**read as ACUITE B**) and short term rating of '**ACUITE A4**' (**read as ACUITE A four**) on the Rs.5.85 crore bank facilities of Senthil Enterprises-JV. This rating is now an indicative rating and is based on best available information.

Senthil Enterprises-JV, established in 2015, is a Tamil Nadu-based partnership firm promoted by Mr. Senthil Kumar and Mr. Palanisamy. The firm is engaged in the removal and transportation of coal overburden.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
