Rating Rationale

Acuité has reaffirmed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) and short-term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs.5.85 Cr bank facilities of Senthil Enterprises-JV. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Senthil Enterprises-JV, established in 2015, is a Tamil Nadu-based partnership firm promoted by Mr. Senthil Kumar and Mr. Palanisamy. The firm is engaged in the removal and transportation of coal overburden.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
