Rating Rationale

Acuite has reaffirmed the long term rating of '**ACUITE D**' (read as **ACUITE D**) and the short term rating of '**ACUITE D**' (read as **ACUITE D**) on the Rs.7.75 crore bank facilities of S M Engineering Works (SMEW). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Mumbai based, S M Engineering Works (SMEW), was established in 2006, is a partnership firm engaged in fabrication and manufacturing of boilers. The partners of SMEW are Mr. M. Sekar and Mr. V. Shanmugam, has an experience of more than two decades in the similar line of business.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
