Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE B' (read as ACUITE B) on the Rs. 14.40 crore bank facilities of Sri Kanakadurga Oil Mill (SKOM). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

The Karnataka-based Sri Kanakadurga Oil Mill (SKOM) established in April 2003 is headed by Mr. G. Srinivasa Rao and G. Aruna Devi who possess experience of around 15 years in the industry. The firm is engaged in edible oil extraction and has installed capacity of 100 tons/day with current utilisation of 60 per cent. The products are sold under the 'Sun Dhara, Aroghya Dhara, KDM Gold' and 'Sun Vishwas' brand names.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer / borrower (in the absence of information provided by the issuer / borrower). Acuité has endeavoured to gather information about the entity / industry from the public domain. Therefore, Acuité cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
