**The issuer did not co-operate; based on best available information.

Acuité has reviewed the long-term rating of '**ACUITE B** (read as ACUITE B)' on the Rs. 8.00 crore bank facilities of V. K. Developers (VKD). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

VKD is a Special Purpose Vehicle (SVP) established in 2015 for developing 'Sikhin Heights', a real estate project at Surat (Gujarat). The firm is promoted by partners, Mr. Kalpesh Patel and Mr. Vimal

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
