Acuité has reaffirmed the long-term rating of 'ACUITE D' (read as ACUITE D) and the short term rating of 'ACUITE D' (Read as ACUITE Do)n the Rs. 114.62 crore bank facilities of S V Refineries Private Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
