**The issuer did not co-operate; based on best available information.

Acuité has reviewed the long-term rating of '**ACUITE B-**' (**read as ACUITE B minus**) on the Rs. 48.00crore bank facilities of Star Wire (India) Vidyut Private Limited (SWIVPL). This rating is now an indicative rating and is based on best available information.

The New Delhi-based, SWIVPL established in 1991 runs a 9.9MW biomass power plant at Khurawata village in Mahendargarh district (Haryana).

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
