Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE B-' (read as ACUITE B minus) n the Rs. 9.50 crore bank facilities of Sri Vijayadurga Industries (SVI). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Sri Vijayadurga Industries (SVI), incorporated in April 1995 as a partnership firm by Mr. G. Srinivas Rao, is engaged in the manufacturing and processing of rice. The firm sells its products under the 'Durgadevi' brand name in Karnataka.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
