Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) and the Short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 6.25 crore bank facilities of GANESH COTTON INDUSTRIES. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

The Gujarat-based, GCI is a partnership firm established in 2013 by Mr. Vitthalbhai Jeevan Patel and others. The firm is engaged in the manufacturing (Ginning and pressing) of cotton bales and has an installed capacity of 12636 MT per annum.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower).
