Acuité has reviewed the long-term rating of '**ACUITE BB+**' (read as **ACUITE double B plus**) and short term rating of '**ACUITE A4+**' (read as **ACUITE A four plus**) on the Rs.20.00 crore bank facilities of Gopal Teknocon Private Limited (GTPL). This rating is now an indicative rating and is based on best available information.

The Vishakhapatnam-based, GTPL was incorporated in 2014 by Shri. Satluri Ramanujam, Shri. Satluri Navin Madhav and Shri. Satluri Pavan Kumar. The company is engaged in the fabrication and erection of storage tanks, pipe lines, heaters, pressure valves along with allied civil construction activity primarily for oil refineries and railways.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
