Rating Rationale

Acuité has reaffirmed the long-term rating of '**ACUITE BB-**' (read as **ACUITE double B minus**) and the short-term rating of '**ACUITE A4+**' (read as **ACUITE A four plus**) on the Rs. 20.00 crore bank facilities of Gopal Teknocon Private Limited (GTPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

The Vishakhapatnam-based, GOPAL TEKNOCON PRIVATE LIMITED was incorporated in 2014 by Shri. Satuluri Ramanujam, Shri. Satluri Navin Madhav and Shri. Satluri Pavan Kumar. The company is engaged in the fabrication and erection of storage tanks, pipe lines, heaters, pressure valves along with allied civil construction activity primarily for oil refineries and railways.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
