Acuite has reviewed the long term rating of '**ACUITE B**' (read as **ACUITE B**) and short term rating of **ACUITE A4** (read as **ACUITE A four**) to the Rs. 19.00 crore bank facilities of TBPR Infra Projects Private Limited (TBPR). This rating is now an indicative rating and is based on best available information.

TBPR, established in 2007, undertakes execution of irrigation projects such as canals, tanks, dams and barrages at Hyderabad (Telangana).

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.
