Rating Rationale

Acuité has reaffirmed the long term rating of '**ACUITE B+**' (read as **ACUITE B plus**) and short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs.13.00 crore bank facilities of Vapi Pigments Private Limited (VPPL). The rating continues to be flagged as "Issuer Not Co-operating" and is based on the best available information.

About the Company

Vapi Pigments Private Limited (VPPL), a partnership firm, established in 1988, is engaged in the manufacture of chemical pigments namely, Chrome, CPC and Beta at Vapi, Gujarat. The company has installed capacity of 150 tonnes per month (Chrome pigments) and 150 tonnes (CPC and beta pigments) per month. The capacity utilisation is around 95 percent. The company is headed by Directors, Mr. Champak Amratlal Shah, Mr. Manish Shivdas Kothari, Mr. Ramdas Narayan Raman and others who possess extensive experience in the business.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
