Rating Rationale

Acuite has reaffirmed the long term rating of '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs. 11.15 crore bank facilities of Nabha Paper Mills Private Limited. This rating continues to be an indicative rating and is based on best available information.

About the Company

NPPL, established in April 1980, is a Sangrur-based company engaged in the manufacturing of kraft paper and duplex board paper. The company is headed by Mr. B. R Jindal.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before the due date.
