**The issuer did not co-operate; based on best available information.

Acuité has reviewed the long term rating of '**ACUITE C**' (read as **ACUITE C**) and the short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs.27.30 crore bank facilities of Vriksh Transworld Holdings Limited (VTHL). This rating is now an indicative rating and is based on best available information.

VTHL, incorporated in the year 1995 is a Chennai-based company promoted by Mr. Manu Goel and family. The company is engaged in the trading of TMT bars, steel scraps and steel products. VTHL sources TMT bars from domestic manufacturers while steel scrap is imported mainly from traders based in USA and Europe.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
