Acuité has reviewed the short-term rating of '**ACUITE A4**' (read as **ACUITE A four**) to the Rs.5.00 crore bank facilities of Quality Spares International (QSI). This rating is now an indicative rating and is based on best available information.

The Noida-based, QSI was incorporated in 2013 by Mr. Vishant Gupta, Mr. Prashant Gupta and Mr. Shiv Kumar Gupta. The firm is engaged in the manufacture and export of tractor linkage parts, agricultural farm implements and other engineering goods at Greater Noida, Uttar Pradesh.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
