Rating Rationale

Acuité has reaffirmed the short-term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 5.00 crore bank facilities of Quality Spares International (QSI). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

The Noida-based, Quality Spares International was incorporated in 2013 by Mr. Vishant Gupta, Mr. Prashant Gupta and Mr. Shiv Kumar Gupta. The firm is engaged in the manufacture and export of tractor linkage parts, agricultural farm implements and other engineering goods at Greater Noida, Uttar Pradesh.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
