Acuite has downgraded the long term rating to '**ACUITE BB-**' (read as **ACUITE double B minus**) from '**ACUITE BB**' (read as **ACUITE double B**) on the Rs.9.20 crore bank facilities of Avis India. The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

Avis India, part of the Avis Group, is a Pune-based civil construction firm established in 1997 by Mr. Vijay Kulkarni. The firm, a licensed PWD contractor undertakes construction of sugar factories and water treatment plants in Maharashtra.

#### Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
