#### **Rating Rationale**

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE Bf)rom 'ACUITE B+' (read as ACUITE B plus)and reaffirmed the short term rating of 'ACUITE A4' (read as ACUITE A four)on the Rs. 22.00 crore bank facilities of Dulichand Industries (DI) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

#### **About the Company**

The Hyderabad-based Dulichand Industries was established by Mr. Gajanand Agarwal and Mr. Anand Agarwal in 1990. The firm is engaged in the manufacture of sunflower and cotton seed refined oil at Gagan Pahad, Hyderabad.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
