Acuité has reviewed the long-term rating of '**ACUITE B+**' (**read as ACUITE B plus**) and short term rating of '**ACUITE A4**'(**read as ACUITE A four**) on the Rs.16.00crore bank facilities of Mahalaxmi Dhatu Udyog Private Limited (MDUPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

MDUPL is a Nagpur-based company established by the Rathi family in 1996. The company is engaged in manufacturing of steel angles and has a production capacity of 24,000 metric tonnes per annum. The company caters to transmission tower manufacturers. The day-to-day operations are managed by Mr. Krishna Rathi and Mr. Varun Rathi.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
