Acuité has reviewed the long-term rating of '**ACUITE BB**' (**read as ACUITE double B**) and short-term rating of '**ACUITE A4+ (read as ACUITE A four plus)**' to the Rs. 8.00 crore bank facilities of Nuetech Solar Systems Private Limited (NSSPL). This rating is now an indicative rating and is based on best available information.

Bengaluru based Nuetech Solar Systems Private Limited (NSSPL), established in 1992 by Mr. Surendra Kumar as a proprietorship firm, was incorporated into a private limited company in 2002. The company is engaged in the manufacture and distribution of solar thermal products like water purifiers, solar PVs etc. The installed capacity stands at 1,500 units per month.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
