**Rating Rationale**

Acuite has reaffirmed the long term rating of ‘**ACUITE D**’ (read as **ACUITE Do**) on the Rs. 17.00 crore bank facilities of Siri Smelters And Energy Private Limited. The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

**About the Company**

Siri Smelters And Energy Private Limited was incorporated in 2011, is an Andhra Pradesh based company, promoted by Mr. Mohan Sajja and Mrs. Jyothsna Sajja. The company started its commercial operation in August 2014. It is engaged in the manufacturing of ferroalloys, mainly, Silico Manganese.

**Non-cooperation by the issuer/borrower:**

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuite’s policies.

**Limitation regarding information availability**

This rating is based on information available from sources other than the issuer / borrower (in the absence of information provided by the issuer / borrower) . Acuite endeavoured to gather information about the entity/industry from the public domain. Any rating with the suffix 'Issuer not cooperating' is assigned without any management interaction with the issuer entity or any data / information from the entity.
