**Rating Rationale**

Acuite has downgraded the long-term rating to '**ACUITE B-**' (read as **ACUITE B minus**) from '**ACUITE B**' (read as **ACUITE B**) and reaffirmed the short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 7.50 crore bank facilities of Chirag Construction Company on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

**About the Company**

Chirag Construction Company (CCC), established in 2008, is a Madhya Pradesh-based civil construction firm promoted by Mr. Mehrudeen Khan. The firm, Class 1A civil contractor, is engaged in the construction of roads for government organizations such as Madhya Pradesh Rural Road Development Authority and Public Work Departments (PWD).

**Non-cooperation by the issuer/borrower:**

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Acuite endeavoured to gather information about the entity/industry from the public domain.
