Acuité has reviewed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) and short-term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 30.00 crore bank facilities of Nowotek Textiles Private Limited (NTPL). This rating is now an indicative rating and is based on best available information.

Established in 2008, NTPL is a Noida-based company headed by Mr. Shobhit Gupta. The company commenced operations from July 2013 to manufacture and export non-woven fabrics at Greater Noida.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
