Rating Rationale

Acuité has downgraded the long-term rating to '**ACUITE B-**' (read as **ACUITE B minus**) from '**ACUITE B**' (read as **ACUITE B**) and reaffirmed the short-term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 5.00 crore bank facilities of Sai Jewellers (SJ) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Bangalore based, Sai Jewellers (SJ) was established in 2007 by Mr. Anand Karmokar. The firm is engaged in designing and manufacturing of gold and diamond jewellery, which includes ethnic jewellery, AD jewellery and real precious stone jewellery. The firm caters to large retailers such as Malabar Gold and Diamonds, Manubhai Jewellers and Swarna Siddhi Jewellers, to name a few. Sai Jewellers has installed capacity of manufacturing 3 kg per day.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
