**Rating Rationale**

Acuite has downgraded the long-term rating to 'ACUITE B- (read as ACUITE B minus)' from 'ACUITE B' (read as ACUITE B) on the Rs. 8.00 crore bank facilities of Enar Rubber Reclaim Industries Private Limited (ERPL) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

**About the Company**

Enar Rubber Reclaim Industries Private Limited (ERPL), a subsidiary of Enar Industrial Enterprises Limited, was incorporated in 2012 by Mr. Rajen Kamani, Ms. Tarulata Kamami and Ms. Bhavya Kamani at Jharkhand. The company is engaged in the manufacturing of reclaim rubber and crumb rubber used to make cycle tyres and conveyor belts for the automobile sector. The manufacturing facilities are located at Adityapur (Jharkhand). The company commenced operations from March, 2014.

**Non-cooperation by the issuer/borrower:**

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

**Limitation regarding information availability**

This rating is based on information available from sources other than the issuer / borrower (in the absence of information provided by the issuer / borrower) . Acuite endeavoured to gather information about the entity/industry from the public domain.
