Rating Rationale

Acuité has downgraded the long-term rating to '**ACUITE B-**' (read as **ACUITE B minus**) from '**ACUITE B**' (read as **ACUITE B**) on the Rs. 21.50 crore bank facilities of Buland Housing Private Limited (BHPL) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Buland Housing Private Limited (BHPL), incorporated in 2006, is engaged in the development of residential projects in Agra. The company is developing two projects, 'Buland City' and 'Buland Vatika' at Agra. The directors of the company are Kamla Sharma and Phundi Lal Sharma.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.
