Rating Rationale

Acuité has reviewed the long-term rating of '**ACUITE BB** (read as **ACUITE double B**) and short-term rating of '**ACUITE A4+** (read as **ACUITE A4+**) on the Rs.5.00 crore bank facilities of Jakhpur Jagdamba Construction Private Limited (JJCPL). This rating is now an indicative rating and is based on best available information.

Jakhpur Jagdamba Construction Private Limited (JJCPL) was incorporated in 2013 by Mr. Suraj Damodar Tatode and Mrs. Kumod Tulsiram Barde, the present directors of the company. JJCPL is engaged in civil construction work and caters to clients like Larsen & Toubro Limited and Elecon Engineering Company Limited among others.

Non-cooperation by the issuer/borrower: Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
