#### **Rating Rationale**

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B) from 'ACUITE B+' (read as ACUITE B plus) on the Rs. 10.50 crore bank facilities of Bhavani Cotton Industries (BCI) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

## **About the Company**

Bhavani Cotton Industries (BCI), established in 2014, is an Andhra Pradesh-based partnership firm engaged in the ginning and pressing of cotton. The firm is headed by Mr. N. Suresh, who has extensive experience in the cotton industry. The installed capacity stands at 26 Gins.

## Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
