Acuité has withdrawn the long term rating of '**ACUITE B** (read as **ACUITE B**) on the Rs.5.85 crore bank facilities of Grand Pinkcity Infraprojects (GPI). This rating is now an indicative rating and is based on best available information.

The rating is being withdrawn on account of request received from the company and NOC received from the bank.

GPI, a partnership firm established in 2014 by Mr. Ajay Jain, Mr. Manju Loonia, Mr. N.K. Jain, Mr. Tarun Jain and others is engaged in the development of residential projects at Jaipur.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
