Acuité has reviewed the long term rating to '**ACUITE B+** (read as **ACUITE B plus**) on the Rs.10.00 Cr bank facilities of Mata Phoolan Wanti Education Society (MPWES). The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

The Delhi-based MPWES, established in 2010 is headed by Mr. S. K Sachdeva. The education society runs the CBSE affiliated, Shree ram World School.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
