Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) on the Rs. 8.00 crore bank facilities of Malar Textiles (MT). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

The Coimbatore-based Malar Textiles, established as a partnership firm in 1997, manufactures grey fabrics. The firm has 28 weaving looms and has taken 500 looms on rent for job work. The installed capacity is 1.70 lakh meter per week. Mr. D.Viswanathamurthy is a partner of the firm.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
