**Rating Rationale**

Acuité has reaffirmed the long-term rating of ‘**ACUITE D**’ (read as **ACUITE D**) and the short-term rating of ‘**ACUITE D**’ (read as **ACUITE D**) on the Rs.8.50 Cr. bank facilities of Shri Ganesh Enterprises (SGE). The rating continues to be flagged as “Issuer Not-Cooperating” and is based on best available information.

**About the Company**

Shri Ganesh Enterprises was established in the year 2001 as a partnership firm by Mr. Amit Jain and Mrs. Rachna Jain in Ernakulam, Kerala. The firm is engaged in the business of Import and trading of Carbon Black, Synthetic Rubber, Natural Rubber, Rubber Process Oil etc. The firm imports these goods from various suppliers of South Korea, Russia, UAE, China and Vietnam and sells across North and south India region. Further, the firm also trades in DEPB license.

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
