Acuité has reviewed the long-term rating of '**ACUITE B**' (**read as ACUITE B**) on the Rs. 20.00 crore bank facilities of Oneworld Corporation Private Limited (OCPL). This rating is now an indicative rating and is based on best available information.

The Delhi based OCPL, established in 1999, by Mr. Amit Gupta, is an importer, manufacturer and exporter of sandalwood oil, spices and perfumes.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
