**The issuer did not co-operate; based on best available information.

Acuite has reviewed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) on the Rs. 20.00 crore bank facilities of Oneworld Corporation Private Limited (OCPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

The Delhi based OCPL, established in 1999, by Mr. Amit Gupta, is an importer, manufacturer and exporter of sandalwood oil, spices and perfumes.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
