Acuité has reviewed the long-term rating of '**ACUITE B+** (**read as ACUITE B plus**) on the Rs.7.00 crore bank facilities of Shreeji Gems Limited (SGL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

SGL, incorporated in the year 1991, is a Mumbai-based company promoted by Mr. Pankaj Patel and Mr. Nagjibhai Patel. The company is engaged in import, export, and trading of rough, cut and polished diamonds.

**Non-cooperation by the issuer/borrower:** Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
