SMERA has reviewed long-term rating of '**SMERA BB+**' (read as **SMERA BB plus**) and short term rating of '**SMERA A4+**' (read as '**SMERA A four plus**') on the Rs. 12.50 crore bank facilities of DELIGHT DAIRY LIMITED. This rating is now an indicative rating and is based on best available information.

Non-cooperation by the issuer/borrower

SMERA has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.

About the Rated Entity

Delight Dairy Limited (DDL), a Kolkata-based company was established by Mr R K Agarwal in 2000 to manufacture pasteurised milk and milk powder (skimmed milk powder (SKM), butter and ghee through its processing facilities at Howrah (West Bengal) and Dewas (Madhya Pradesh).

For FY2014-15, the company reported PAT (profit after tax) of Rs.0.17 crore on operating income of Rs.88.68 crore, compared with PAT of Rs.0.14 crore on operating income of Rs.82.89 crore in FY2013-14.
