Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs. 10.00 crore bank facilities of Sree Bhuvaneswari & Co. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Sree Bhuvaneswari & Co., a Chennai-based proprietorship concern established in 1975 by Mr. A. Dasaradaiah (HUF) trades in pulses and dal (Black gram, Urad dal among others).

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
