Rating Rationale

Acuité has reaffirmed the short-term rating of 'ACUITE D' (read as ACUITE Do) n the Rs. 24.00 Crore bank facilities of Komal Fashion (KF). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

Komal Fashion (KF), incorporated in 2011, is an Ahmedabad-based firm promoted by Mr. Gaurav Amin. The firm is engaged in the trading of raw cotton and manufacturing of garments.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
