Acuité has downgraded and withdrawn the long-term rating to '**ACUITE B+** (read as **ACUITE B plus**) from '**ACUITE BB-**' (read as **ACUITE double B minus**) on the Rs.7.50 crore bank facilities of Sri Suresh Poultry Complex (SSPC). The rating withdrawal is in accordance with the Acuité's policy on withdrawal of rating. This rating is now an indicative rating and is based on the best available information.

The rating is being withdrawn on account of request received from the company and NOC received from the banker.

SSPC was started by Mr. Trinadha Reddy in 1994 for selling of eggs, rearing of broiler birds and other poultry products. The management of SSPC has experience of more than two decades in the given line of business. The firm has its own farm and feeds unit. The day to day operations of the firm is managed by Mr. K. Venkata Reddy and Mr. Sunil, who are well supported by experienced and qualified professionals.

Non-cooperation by the issuer/borrower

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

CARE, vide its press release dated August 31, 2020 had denoted the rating of Sri Suresh Poultry Complex (SSPC) as 'CARE B+/Stable (Downgraded; Issuer Not Cooperating)' on account of lack of adequate information required for monitoring of ratings.
