Rating Rationale

Acuite has Reaffirmed the long-term rating of '**ACUITE D**' (read as **ACUITE D**) and the Short-term rating of '**ACUITE D**' (read as **ACUITE D**) on the Rs. 27.30 Cr. bank facilities of Sigma C Infrastructure Private Limited (SCIPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

The Kolkata-based SCIPL was established as a proprietorship firm in 1993 by Mr. A K Bhasin (Chairman) and reconstituted as a private limited company in September 2012. The company is engaged in the execution of turnkey contracts for the power industry. It undertakes supply, erection, testing, and installation of equipments, auxiliaries, motors for generating stations and switch yards apart from civil work. SCIPL is also engaged in the underground laying of cables and jointing works, installation of third rail and traction substations for Metro Railways. Additionally, it has also diversified into water distribution and drainage projects in Assam.

Unsupported Rating

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
