Acuité has reaffirmed the long-term rating of 'ACUITE B' (read as ACUITE B) and shortterm rating of 'ACUITE A4' (read as ACUITE A four) on the Rs.7.00 Cr bank facilities of Flexo Foam Private Limited (FFPL). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
