Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B) from 'ACUITE B+' (read as ACUITE B plus) and reaffirmed the short term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 11.00 crore bank facilities of Murti Udyog Limited (MUL) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Murti Udyog Limited (MUL), incorporated in 2008, is a New Delhi based company engaged in the manufacturing of aluminium rods, wires and conductors used in the electricals industry. The operations are managed by Mr. Praveen Goyal and Mr. Naveen Goyal.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
